

Ten Frequently Asked Questions (FAQs)

Questions are quoted as I received them directly from our community.

1. One of my students was selected for the golden ticket winner for the Holiday Express event but they did not go. Can he still receive his gift? It would make him really happy.

The staff at the Family Resource Center has gone above and beyond to make sure every child receives their gift, even if they were unable to attend the event. All remaining gifts and gift cards have been personally delivered to the respective school sites over the last several days. This ensures that every child, including your student, can still enjoy their well-deserved gift. I greatly appreciate the hard work and commitment of the FRC staff in making this possible.

2. Can my daughter take her Chromebook to Mexico with her during the holidays? Will it work there?

Your child may take the District-issued Chromebook to Mexico. We encourage ongoing learning, also known as 24/7 learning, and are pleased to support her education while traveling. Please note that while the District Chromebook will work with available Wi-Fi networks in Mexico, the District-provided hotspots are not functional outside of our service area. We recommend identifying reliable Wi-Fi access during your trip to ensure uninterrupted use of the device. We ask that the Chromebook be returned upon your daughter's return to continue supporting her learning at school.

3. We take surveys all the time, but I do not always hear about the results. What were the results of the Technology Survey we just took?

Technology plays a critical role in enhancing teaching and learning across our schools. These survey results underscore its impact. Thank you to everyone who participated and for your ongoing efforts to integrate technology in ways that support student success.

Classroom Integration


- 75% of teachers report daily Chromebook use in their classrooms, with nearly 20% using them weekly.
- This aligns with student feedback, where 77% report daily use and 16% report weekly use.


Home Use

4. Can you confirm when students will return back to school after the break?

We will welcome our students when they return back to school on Monday, January 6, 2025. We look forward to seeing all of our students on that day as school attendance is very important. Here are some facts to consider:





5. Will our Police Department be working over the winter break to protect our schools?

Our SUSD Police Department is a police agency that operates twenty-four hours a day, seven days a week. The Department is open 365 days a year and is not closed for holidays. The Department is allotted 35 positions for sworn staff however they currently have 25 sworn positions filled and two additional trainee positions in the Academy. This includes their management positions which include the Chief, a Lieutenant, and six sergeants. Their active patrol staff consists of 17 sworn officer/corporals who cover the various shifts which include dayshift, swing shift and graveyard shift to ensure 24/7 coverage.

6. You are not going to have any programs during winter break. That is hard on my family since I work. I need to prepare if you will not be having any programs for spring break. Will there be anything?

The ELOP department will have their Spring Break Day Camp from March 17th–March 20th. This exciting program will offer safe, engaging, and fun learning opportunities for students during Spring Break. Here are a few key details:

7. How do I receive access to the \$500 of supplies for each teacher?

SUSD recognizes the importance of providing adequate classroom materials and resources to support effective teaching and learning. Outlined below is the process to spend the \$500 per classroom teacher for educational materials directly related to classroom education. The only allowable vendor is Southwest School and Office Supply. Orders should be submitted using the Escape Online Shopping process, as normal. Each teacher should stop shopping at \$460 because the total allocated includes tax. Teachers can browse the Southwest website, build lists, and create PDFs to help the Requisitioner place their orders by using the **browse-only** login through the following website: Visit

8. I received notice to pre-register for high school during 8th grade parent night. Do I have to pre-register my child so early?

We encourage all 8th grade parents to attend. Pre-Registration Night provides students and their families with essential information about the high school experience. It addresses critical areas such as course selection, graduation requirements, and


extracurricular opportunities. This proactive approach reduces anxiety and promotes a sense of preparedness.

Parents and students are introduced to academic pathways, advanced placement (AP) options, career technical education (CTE) programs, and specialized pathways available at their respective high schools. Early exposure to these opportunities helps students make informed choices about their academic and career trajectories.

In addition, the Pre-Registration Night ensures that all families, regardless of background, have access to critical information about high school programming. This inclusivity supports equity in education and ensures that no student is left behind in understanding their educational options.

9. Are you doing any events for MLK Day?
