Awarding Lease-Leaseback Contracts for the Kennedy Portable Replacement Project and the Montezuma Portable Replacement Project

WHEREAS, the Stockton Unified School District ("District") desires to utilize the lease-leaseback delivery method for the construction of the Kennedy Portable Replacement Project and the Montezuma Portable Replacement Project ("Projects"); and

WHEREAS, pursuant to Education Code sections 17400 and 17406, school districts must award lease-leaseback contracts based on a competitive solicitation process to the proposer providing the best value to the district; and

WHEREAS, on November 14, 2017, the Board of Trustees ("Board") approved Resolution No. 17-22 and adopted the procedures for evaluating qualifications of lease-leaseback contractors in accordance with Education Code sections 17400 and 17406; and

WHEREAS, a Request to Prequalify and for Statement of Qualifications for Preliminary and Construction Services ("RFQ") in accordance with Education Code sections 17400 and 17406 was issued and a pool of qualified firms ("Pool") was established; and

WHEREAS, on February 16, 2018 the District issued to the Pool a Request for Sealed Proposals for Construction Services to complete the Projects; and

WHEREAS, based upon the proposals submitted, it has been determined that the proposals of Roebbelen Contracting, Inc. provide the best value to the District for the Projects; and

WHEREAS, the Governing Board now determines it appropriate to award the Projects to Roebbelen Contracting, Inc., and authorizes staff to take all actions necessary for the completion of the associated Contracts and of the Projects as contemplated in the Contract Documents.

NOW, THEREFORE BE IT RESOLVED that the Governing Board does hereby determine and order as follows:

Section 1. <u>Recitals</u>. The above recitals are true and correct, and the Governing Board hereby so finds.

Section 2. <u>Findings</u>. The Governing Board hereby finds that all the terms and conditions necessary to award the Project have been met.

Section 3. <u>Award</u>. The Governing Board hereby approves the award of the Kennedy Portable Replacement Project and the Montezuma Portable Replacement Project to Roebbelen Contracting, Inc.
