Summer Learning Academy (SLA) 2021-- CSEA 821 One-time adjustments to salary and overtime:

ALL CSEA 821 members, working less than 12 months at high school or department services **working the SLA** in the following classifications will receive an additional 15% increase to their salary for all time worked between June 1<sup>st</sup> and July 23<sup>rd</sup>. Any regular hours worked will be compensated at the normal hourly wage plus 15%. Any hours worked in excess of 8 hours will be compensated at the overtime rate plus 15%. **All members shall be paid based on their permanent classification, regardless of SLA position.**

**\*Employees must submit a timesheet for SLA as the work performed.**

All CSEA 821 members, working less than 12 months at elementary sites **working the SLA** in the following classifications will receive 36 hours (three (3) hours per day for the period from June 3, 2021, to June 18, 2021) at 15% above hourly rate, as agreed for additional SLA duties. Members in the following classifications working in the SLA after the conclusion of the end date of their regular contracted days will receive a 15% increase to their salary for days worked. Any hours worked in excess of 8 hours will be compensated at the overtime rate plus 15%. **All members shall be paid based on their permanent classification, regardless of SLA position.**

**\*Employees must submit a timesheet for SLA as the work performed.**

COVID 19 Sanitation Overtime Dates – for Summer Learning Academy sites

For any member working overtime will be paid on range 33, Step A.

Timesheets should indicate “COVID 19 SANITATION OVERTIME” as the work performed.
