Stephanie Zulueta, Administrative Assistant, Rosemary Reyes, interpreter, and our 2 Parent Liaisons, Maggie Canela, and Charles Watkins. Totaling 29 attendees.

3.0 Changes to Agenda - There were no changes to the agenda

4.0 Read and Approve Minutes - Angelina Aranda (Secretary) PAC experienced technical difficulties and were unable to print documents. All Documents were emailed to the most current and up to date member email information.

Members were given a couple of minutes to review minutes for April 1, 2021 they were also displayed on the screen. Veronica Merino represents 3 schools, but only 2 showed her name, Mrs. Merino was present for this meeting correction was made. Mrs. Merino made a correction in the Spanish minutes version, 6.1 Elections: word *mimbra* corrected to *miembro*.

Mr. Jesus Garcia made the first motion to approve the minutes and Selena Johnson seconded it. All members voted in favor and 0 opposed. Motion carried. Members also reviewed minutes from September 2, 2021. No corrections were made to September 2, 2021 minutes. Jesus Garcia made the first motion to approve the minutes and Alicia Rico seconded it. All members voted in favor and 0 opposed. Motion carried.

5.0 Old Business

5.1 Approval of Bylaws - Monique Guerrero (Parliamentarian) explained to members that on September 2, 2021 Bylaws were reviewed, so she asked for 2 motions to approve them. Jesus Garcia made the first motion and Sherry McClain seconded it. All members present were in favor and 0 opposed. Motion carried.

5.2 Survey Result/ Suggestions to Improve Mailings - Monique Guerrero (Parliamentarian) reviewed survey results as follows:

6.0 New Business

6.1 New funding and grant presentation - Dr. Israel Gonzalez, LCAP Director
Dr. Gonzalez shared that this plan was presented and shared at the Board Meeting on Tuesday October 12, 2021. He told members that the Federal Government recognized that there was going to be a negative impact for our students because of COVID 19 pandemic, and because of that there were some funds allocated to all school districts across the state. In order for Stockton Unified School District to receive those funds we need to make sure we apply for them. **ESSER** stands for **E**lementary and **S**econdary **S**chool **E**mergency **R**elief. He explained that ESSER can connect with the SUSD vision, which is to graduate every student college, career and community ready.

ESSER III Targets:

1. Address the academic impact of lost instructional time.
2. Provide strategies for safe, continuous in-person learning.
3. Provide strategies to support student learning.

ESSER III Requirements:

1. Community engagement and input
2. Have plan presented and approved by school board by October 31st, 2021
3. Spend the funds by September 30th, 2024

Dr. Israel Gonzalez told the members that the amount of the grant is \$156,000,000 for the district to spend within 3 years.

Community Input:

1. LCAP Input
2. Expanded Learning Opportunities input
3. Ongoing Stakeholder input

Some of the community input is coming from the LCAP reviews and comments. We are using this input so we know we are going to be using these funds properly.

- Learning Spaces

These are some of the ideas that SUSD have but would like to continue to hear from all the community. There is a survey available in English and Spanish available in the chat box. Dr. Gonzalez invited all members to participate to help allocate the grant funds better. There is an option to comment in the survey in case it is not already listed. Member Jesus Garcia asked Dr. Gonzalez what was the best way to share this important presentation with the parents that were not present today. Dr. Gonzalez told members that this presentation will be shared with most parent meetings, and the presentation will also be available in the SUSD and PAC minutes link website. We are hoping to get this plan approved. If this plan passes Dr. Gonzalez will come back to revisit the plan and review how this will be applied and what the next steps will be. He invites everyone to participate in the survey.

6.2 Duties of Officers - Angelina Aranda (Secretary) Reviewed duties of the officers from Bylaws Article 7.

ARTICLE VII: DUTIES OF THE EXECUTIVE OFFICERS

Section 1. It shall be the duty of the President to preside at all the meetings.

Section 2. In the event of the absence of the President, the Vice-President shall assume the duties of the President. The Vice-President will also assist the Secretary in calling members.
