6.2 Social Emotional Learning Pedro Heredia Mental Health - Monique Guerrero (Parliamentarian) welcomed Mr. Heredia.

Mr. Pedro Heredia talked about Social Emotional Learning.

He said Social Emotional Learning is a process through which all young people and adults acquire and apply the knowledge, skills, and attitudes to develop:

- 1. Healthy identities
- 2. Manage emotions
- 3. Achieve personal and collective goals
 - 4. Feel and show empathy for others
- 5. Establish and maintain supportive relationships
 - 6. Make responsible and caring decisions

Dr. Heredia said that there are **FIVE CORE COMPETENCIES**:

1. Self-awareness

The ability to accurately recognize one's own emotions, thoughts, and values and how they influence behavior.

- -Identifying emotions
- -Accurate Self-Perception
- -Recognize Strengths
- -Self-Confident
- -Self-Efficacy

2. Self-management

The ability to successfully regulate one's emotions, thoughts, and behaviors in different situations

- -Impulse Control
- -Stress Management
- -Self-Discipline
- -Self-Motivation
- -Goal Setting
- -Organizational Skills

3. Social awareness

The ability to take the perspective of and empathize with others, including those from diverse backgrounds and cultures

- -Perspective-Taking
- -Empathy
- -Appreciating Diversity
- -Respect for Others

"Respect to others and what they are going thru"

4. Relationship skills

The ability to establish and maintain healthy and rewarding relationships with diverse individuals and groups

- -Communication
- -Social Engagement
- -Relationship Building
- -Teamwork


5. Responsible decision making

The ability to make constructive choices about personal behavior and social interactions based on ethical standards, safety concerns, and social norms

- -Identifying Problems
- -Analyzing Situations
- -Solving Problems
- -Evaluating
- -Reflecting
- -Ethical Responsibility

Mr. Heredia presented Stockton Unified School District Multi-Tiered System of Support (MTSS)

MTSS is an integrated, comprehensive framework that focuses on all students' academic, behavioral, and social-emotional learning through the delivery of viable curriculum and effective research-based instructional strategies and supports to ensure equitable outcomes.



Benefits : Academic standpoint, students who participated in SEL programs saw an 11 percentile increase in their overall grades and better attendance

Individual level

students better cope with emotional stress, solve problems, and avoid peer pressure to engage in harmful activities

Mr. Heredia shared that "Mental health & Behavior Support Services was created on July 1, 2018 as part of Stockton Unified School District's effort to create learning environments that are safe, nurturing, consistent, and that work for all students. The supports, services, and programs

offered through MH-BSS help promote the healthy social-emotional development of all students and address behavioral and mental health-related barriers to learning."

Mr. Pedro Heredia shared with our members and guests the background of his own personal experience in his department, his school site is at Franklin "there are so many enrichment opportunities for what students may need. Providing social emotional learning abilities, direct therapy or treatment, individual or group sessions, evaluations, assessments, observations, family therapy, participates in district parent ,site meeting, workshops, support in crisis intervention, Professional Development offered to staff based on the needs of the site Participation in SSTs, 504 Plan Meetings; CARE Team Meeting."

At the end of his presentation parents were highly engaged and interested in obtaining a copy or email of his well explained powerpoint presentation. He let parents know all his school and department information, regardless if parents don't belong to his site. He extended his help to anyone that may need it.

6.3 LCAP Overview /ESSER III Results Dr. Israel S. Gonzalez LCAP Director - Monique Guerrero (Parliamentarian) welcomed Dr. Gonzalez.

Dr. Gonzalez briefly reviewed LCFF; "California's Local Control Funding Formula (LCFF) provides Base, Supplemental, and Concentration (S&C) funding to school districts. S&C funds are funds targeted to

improve student outcomes for all students, especially for English learner, foster youth, and low-income students"

He also reviewed LCAP: The Local Control Accountability and Plan (LCAP) shows how these funds will Improve student outcomes and performance for all students. This plan has been around since 2012.

Dr. Israel S. Gonzalez also pointed out that he has seen that our district shows 8 State Priorities services, but he feels that it should instead be 10 and he listed them

- 1. Basic Services
- 2. Academic Standards
- 3. Parent Involvement
- 4. Student Achievement
- 5. Student Engagement
 - 6. School Climate
 - 7. Course Access
 - 8 Student compound
- 8 Other Student Outcomes

Plus 2

- 9. Expelled Youth

"These 8 priorities are really under 3 main categories"

- 1. Learning
- 2. Supporting Student outcomes
- 3. Engagement

Dr. Gonzalez said when he comes back next meeting he will continue his presentation and will review Goal #1 in LCAP.

ESSER III \$156,422,544 (funds to be used by September 30th, 2024) The Elementary and Secondary School Emergency Relief Funds (ESSER III) are appointed to Local Educational Agencies (LEAs) to address the impact od COVID-19 on elementary and secondary schools.

Dr Gonzalez talked about how the ESSER Plan was approved by the Board. Most of the answers and recommendations needed for the ESSER survey were already on the LCAP. Those responses will be reviewed to help out facilities in need.

Areas that emerged-

English Learner Services, Equity, food, clothing closets/homeless, campus cameras and security, student safety, social emotional support, college, career, transportation needs, extra curricular activities, assemblies, parent support, community liaisons, workshops, field trips, mental health, vaccine, clinicians, facility repairs, improvements, district hotline, counseling and counselors, outdoor learning spaces, nurses, sensory equipment, Special Ed support, safety routines, art and music, STEM, academic supports, intervention, aides, library books, more staff, subs, bilingual support, additional training, additional opportunities for growth, student incentives, additional

workshops, update learning facilities, PD professional development, technology, material, resources, tutoring.

He invited everyone to let family, friends, and community know that SUSD is hiring, is looking for additional tutors, bilingual aids, and many other positions in the education field.

Mrs. Lucila Mendoza made a suggestion to Dr. Gonzalez, asking him to please bring in a future PAC meeting a presentation on how the district can promote parent participation, since parent involvement is in one of the priorities.

*President Martha Hernandez asked for two motions to extend the meeting thirty minutes. Lucy Vega made the first motion, and Tamara Engaling seconded the motion. All members were in favor, no one opposed. Motion carried.

6.4 Parent Involvement Policy - Charles Watkins (Parent Liaison) presented to all members and guests 2021-2022 Parent and Family Engagement Survey.

7.1 Counseling Department, Dr. Jose Cardenas School Counselor Program Specialist

Dr. Cardenas let members and guests know that the counseling department hired 6 new counselors, 2 at Chavez, 2 at Stagg, 1 at Franklin, and 1 at Edison, and are looking forward to hiring 2 more. Counselors will work with students that are missing credits, and also to connect and assist them. This is a new program that will help students that are struggling with social emotional learning, and academic performance. Counseling department really wants to make sure they provide as many services as possible. Counselors will start parent workshops on Tuesdays and Thursdays at 5:00pm.

Counselors in the k-8 level are currently working in social emotional learning specifically; bullying. Dr. Cardenas also reminded everyone that Race-to-Compete opened on October 1st, 2021. Workshops are being offered for students in high school including one-on-one assistance. Race-to-Compete will continue until March 2nd, 2022. Counseling department is there to help and assist parents.
