- 3.0 Changes to Agenda: N/A
- 4.0 Reading and Approval of Minutes: Mrs. Johnson reminded all members that minutes were sent out via mail to be pre-read and revise. Aracely Vargas (Parent Liaison) shared the minutes on the screen to show the rest of attendees. Angelina Aranda made a motion to correct "Arana" to "Aranda" on 4.0. Change "Newson" to "Newsom" on 6.1. On 2.0 change "members" to "members" and on 6.0 "well being" to "well-being" in the English minutes and approve the minutes for the September 3, 2020 meeting with the corrections. - 5.1 Learning Continuity and Attendance Plan- Dr. Sloan (LCAP Coordinator) shared the Learning Continuity and Attendance Plan with all the attendees. He reminded the parents that the district continues to provide responses to parent questions about distance learning and in person instructional. The district continues to provide training and professional development to all the staff. All K-12 teachers receive Professional Development on the newly adopted curriculum for ELA and math. Dr. Sloan reminded parents that there are varies support systems that have been put into place to support the student's mental health, social-emotional, well-being, student engagement and outreach.
