6.0 *New Business:*

6.1 **LCAP Recommendations-** Dr. Connor Sloan (LCAP Coordinator)- presented the Local Control & Accountability Plan (LCAP) 2020-2021 Review & 2021-2024 Year 1 Development. The presentation was available on the screen and he shared the link in the chat box to download the document in English and Spanish. He reviewed the 3 main components: 1. Funding- Local Control Funding Formula (LCFF) with 3 types of funding

1. Base Grant- a base amount of money for every student, 2. Supplemental Grant- additional money for English Learners (EL), low-income students (SES) and Youth in foster care (FY) and 3. Concentration Funding- for districts that have 55% or more student population of English Learners, low-income students and Youth foster care receive additional funding. He reviewed the 8 state priorities that the district focuses to improve student achievement- Basic Services, Academic Standards, Parental Involvement, Student Achievement, Student Engagement, School Climate, Access to Courses and Other Student Outcomes. He also reminded the attendees the mission for SUSD is to graduate every student college, career and community ready.

He reviewed the 3 District Goals that have the 8 state priorities imbedded in the goals. **Goal 3: Meaningful Partnerships-** State & Local Priorities- 3: Parental Involvement and 5: Pupil Engagement- Create a culture of inclusion and collaboration with families and community stakeholders that builds meaningful partnerships focused on increasing student engagement and family and community participation in support of developing leadership at all levels. **Examples of LCAP funded Support:** Family Workshops and Training, Student Clubs & Leadership Activities, Parent Liaisons, Peer Leaders Uniting Students (PLUS) Program, Truancy Outreach, Student Attendance Incentives, Arts & Music Program, Translators & Interpreters, Native American Indian Center and Student Transportation Resources. All the people present were given time to ask questions and make suggestions to the goal that was reviewed. Parents gave suggestion and Dr. Sloan took notes.
