- <u>Slide 10 Comprehensive School Profile (Preliminary)</u>: Replace the image with an image of the school site's Comprehensive School Profile cover page. If the Comprehensive School Profile is available electronically capture the image using the "Snippet Tool", copy and paste. If the Comprehensive School Profile is available in hardcopy, scan (in color) as a jpeg then insert the image. - <u>Slide 12 Title I Funding</u>: Replace using the school site's total Title I funding which includes the 1% Parent monies. All red font is to be changed to white.

- <u>Slide 16 Questions?</u>: Replace content with the principal and school contact information. All red font is to be changed to white.
