OMNI's NEW MAC/Near MAC Notification Process

U.S. OMNI is excited to introduce a streamlined MAC/Near MAC notification process.



As of February 2021, OMNI will provide fund changes to adjust and/or stop the contribution amount of an employee to avoid excess deferrals over their Maximum Allowable Contributions (MAC) limits.

OMNI will provide a fund change at the beginning of the calendar year to restart any contributions for employees who reached their MAC in the previous year. Please know that anyone who reached his/her MAC in January of 2021 will be included in this new fund change process. This new process alleviates the administrative burden of manually adjusting the contribution amounts within your payroll system and mitigates returned contributions.

In addition, regular fund change notifications will now be sent on your organization's selected payroll close date and will contain all upcoming changes for that payroll date. Most close dates occur 8 days prior to the payroll date, although for some Employers it may be earlier. Below are examples of both fund change reports. Please contact your Client Relations Manager or Remittance Specialist with any questions regarding this change.
