Statement Regarding Governor's California Safe Schools for All Plan

Stockton Unified School District is aware of the Governor's [California Safe Schools for All Plan released on Wednesday, December 30](#). The plan's framework consists of four pillars: (1) Funding; (2) Safety and Mitigation; (3) Oversight and Assistance; (4) Transparency and Accountability. We applaud the Governor's efforts to help students safely return to school. Families can learn more about his plan online at www.cdph.ca.gov.

The District has worked hard to create a plan for our students' safe return to school in a Hybrid/Blended Learning Model, tentatively scheduled for later this month. Input from our unions, leaders, staff, students, and families was critical to finalizing our plans. We would like to thank the more than 6,600 families who completed our latest survey in November.

About our plan:

In our current plan, all PK-12th grade students will return in a Hybrid/Blended Learning Model when circumstances allow. Please note that families who would like their students to continue in a 100% Distance Learning Model *will* be able to opt for this.
