Dear Stockton Unified Students, Families and Staff,

Today, the Governor issued a new Stay at Home Order that will go into effect within 48 hours in regions with less than 15% Intensive Care Unit (ICU) availability. San Joaquin County is part of the San Joaquin Valley region which is expected to fall within this range in early December. The order prohibits private gatherings of any size, closes sector operations except for critical infrastructure and retail, and requires 100% masking and physical distancing in all others.

The order will remain in effect for at least 3 weeks and after that period will be lifted when a region's projected ICU capacity meets or exceeds 15%. This will be assessed on a weekly basis after the initial 3 week period. Learn more about this order at covid19.ca.gov.

The health and safety of our staff and students continues to be our top priority. Please note the following operational updates for SUSD:

Day Camp and Afterschool Programs

The new Stay at Home Order allows our SUSD Day Camp Program and after school programs to continue operating. These programs will continue as scheduled with all COVID-19 safety protocols in place.

Athletics

As of now, athletic conditioning may take place after school hours. All conditioning will continue as scheduled with COVID-19 safety protocols in place.

Internal Operations

Administrators and supervisors are encouraged to continue their rotating/staggering of employee schedules. We are asking that <u>all</u> meetings take place virtually to avoid the mixing of more than three households. If employees have questions or concerns, they are asked to contact their direct supervisor. We ask all employees to continue abiding by COVID-19 safety protocols.

Meal and Curriculum Distribution

The District will continue to provide essential services, including the distribution of meals and curriculum to students. All distribution will continue as scheduled with COVID-19 safety protocols in place. Please visit www.stocktonusd.net/MealService to view the meal distribution schedule.

Guidance for Events

Only essential events may be held over the next several weeks. This includes <u>only</u> distribution of curriculum, technology, meals, and flu clinics. All other events (including, but not limited to, picture days, toy drives, craft kit drives, clothing drives, and incentivized events such as PBIS, attendance, athletic signings, etc) must be postponed until the order is lifted in San Joaquin County.
