**THE ANNUAL CALPERS OPEN ENROLLMENT FOR HEALTH BENEFITS WILL BE HELD FROM SEPTEMBER 21, 2020 THROUGH OCTOBER 16, 2020.**

Open enrollment is an annual event and an opportunity for eligible retirees to enroll, change plans, or modify dependents. Your present 2020 plan election will remain in place through December 31, 2020. All current participants will receive information from CalPERS regarding the open enrollment period and plan offerings. The District's annual health plan changes and costs are effective January 1, 2021.

**2021 CHANGES TO HEALTH PLAN OPTIONS**

There are no co-pay or co-insurance changes to existing health plans and no new health plans have been added for the 2021 plan year. Please take the time to review all of the plans for your consideration during this Open Enrollment period. **HEALTH PLAN ELIGIBILITY BY ZIP CODE**

Some health plans are only available in certain counties. Your home zip code will determine which CalPERS health plans you can enroll in. Please visit <https://www.calpers.ca.gov/page/active-members/health-benefits/plans-and-rates/zip-search> to search for available plans in your area.

**No action is needed for Retirees who are not making changes to their health plans.**

Retirees who want to make changes to their health plans during Open Enrollment, will submit the request directly through CalPERS. Plan changes can be made online by accessing your myCalPERS account <https://my.calpers.ca.gov/> If you have any questions, or need online assistance, please call CalPERS 1-888-225-7377.

Although CALPERS deducts the full medical premium out of a retiree's monthly pension warrant, the District provides a reimbursement to qualified early retirees towards their health premium. The SUSD Payroll department will process this reimbursement each month.
