### Description

Provides one time limited assistance to prevent homelessness or to assist homeless households obtain permanent housing. A "last resort" assistance restricted to household with no other resources who either in emergency shelters or will become homeless without program assistance. Assistance includes security deposit, one month rent, two months back rent, utility deposit assistance, and moving assistance.

Program cannot help people wanting to voluntarily move. Those with assistance from the Housing Authority does not qualify.
